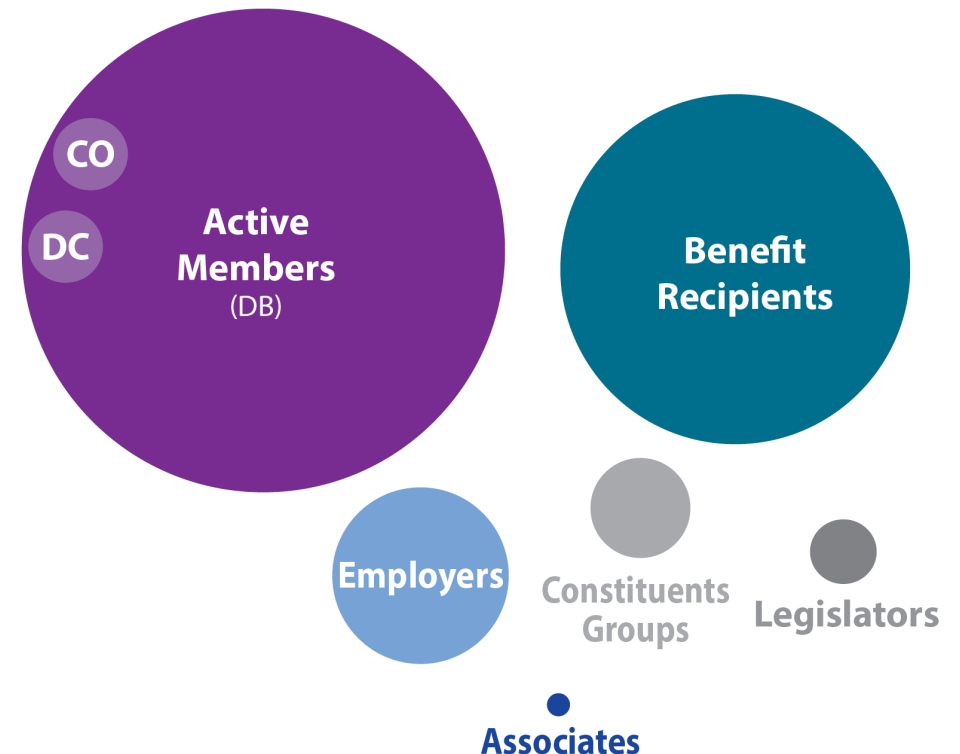

The Auditor of State's special audit of the retirement system was completed last year and found no evidence of fraud, illegal acts or data manipulation related to the funds held in trust by STRS Ohio for its members.

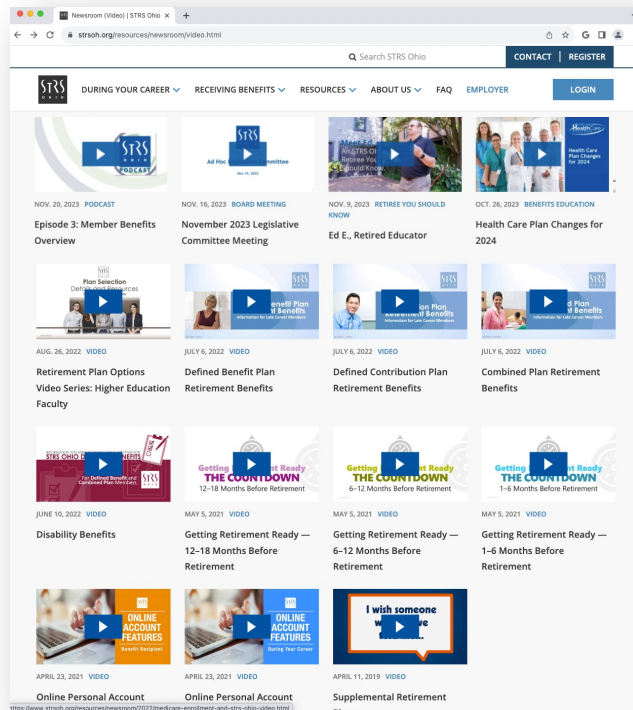
